What does the Fund invest in?

Until September 6, 2017:

The Fund aims to provide long-term capital growth by investing primarily in the common shares of companies located throughout Asia, including Japan.

Subject to securityholder approval, effective September 6, 2017:

The Fund aims to provide long-term capital growth through exposure to common shares of companies located throughout Asia, including Japan by investing primarily in Underlying Funds and/or directly in securities.

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund’s returns change over time. This is called “volatility”.

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Investors Group has rated the volatility of this Fund as **medium to high**.

This rating is based on how much the Fund’s returns have changed from year to year. It doesn’t tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

No guarantees

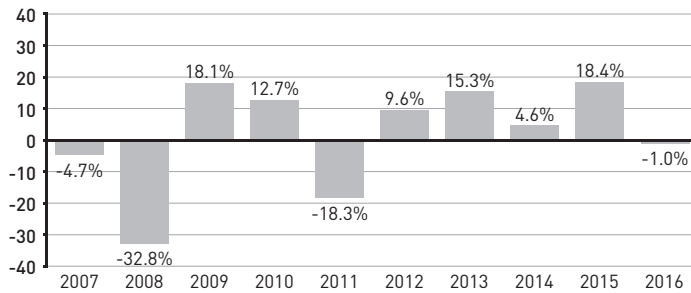
Like most mutual funds, this Fund doesn’t have any guarantees. You may not get back the amount of money you invest.

How has the Fund performed?

This section tells you how Series B securities of the Fund have performed over the past 10 years. Returns are after Fund expenses have been deducted. These expenses reduce the Fund’s returns.

Year-by-year returns

This chart shows how Series B securities of the Fund performed in each of the past 10 calendar years. The Fund dropped in value in four of the 10 years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series B securities of the Fund in a 3-month period over the past 10 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

A person who invested \$1,000 in the Series B securities 10 years ago would have \$1,251 as of May 31, 2017. This is equal to an annual compounded return of approximately 2.3%.

Who is this Fund for?

You should consider investing in this Fund if you are comfortable with the risks for this investment and:

- your long-term investment goal is capital growth; and
- you intend that this investment be one component of a diversified investment portfolio and you are comfortable with the potential for a high level of volatility for this investment.

A word about tax

In general, you’ll have to pay income tax on any money you make on the Fund. How much you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your Fund in a non-registered account, taxable fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series B securities of the Fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

You can only buy this series of the Fund under the following sales charge purchase option.

Investors Group may pay your Consultant an additional payment of up to 40% of the sales bonus if they are in their first four years with us.

2. Fund expenses

You don't pay these expenses directly. These expenses reduce the annual return of the Series.

For the year ended March 31, 2017, the annualized expenses of the Series totalled 3.31% of its value (about \$33 for every \$1,000 invested).

Management expense ratio (MER) This is the total of the Series' management fee (including the trailing commission) and operating expenses (including the service fee and administration fee).	2.83%

The above MER does not fully reflect any service, administration and/or management fee reductions that have occurred within the past 12 months for this series.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the Fund.

Fee	What you pay
Excessive switching fee	If you switch into, or out from, the Fund so often that in our view your switches could have a detrimental effect, we may charge you up to 3.00% of the amount you switch.
Short-term trading fee	Up to 2.00% of the amount you sell or switch within 90 days of investing in the Fund. This fee is payable to the Fund.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the Fund. It is for the services and advice that your Consultant provides to you.

Investors Group pays the trailing commission to your Consultant. It is paid in whole or in part from the Fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose and ranges between:

- 0.57% to 0.80% per year (about \$6 to \$8 per year for every \$1,000 invested).

For all Units after December 31, 2017 – 0.40% to 0.60% per year (about \$4 to \$6 per year for every \$1,000 invested).
