What does the Fund invest in?

The Fund aims to provide total return consisting of income and potential capital appreciation by investing primarily in fixed income securities from around the world.

How risky is it?

The value of the Fund can go down as well as up. You could lose money. One way to gauge risk is to look at how much a fund’s returns change over time. This is called “volatility”.

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

No guarantees

Like most mutual funds, this Fund doesn’t have any guarantees. You may not get back the amount of money you invest.

How has the Fund performed?

This section tells you how Series P securities of the Fund have performed. Returns are after expenses have been deducted. These expenses reduce returns.

Year-by-year returns

Risk rating

IG Wealth Management has rated the volatility of this Fund as **low**. Because this is a new fund, the risk rating is only an estimate by IG Wealth Management. Generally, this rating is based on how much the Fund’s returns have changed from year to year. It doesn’t tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

Who is this Fund for?

You should consider investing in this Fund if you are comfortable with the risks for this investment and:

- your long-term investment goal is income with a growth component; and
- you intend that this investment be one component of a diversified investment portfolio.

This Fund is not available for retail purchase. It is solely for the investment, directly or indirectly, of other IG Wealth Management Funds or institutional investors.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series P securities of the Fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

Generally, there are no purchase options that attract sales charges.

2. Fund expenses

You don't pay these expenses directly. These expenses reduce the Series' annual return. The Series' expenses are made up of the management fee, operating expenses (including the administration fee) and trading costs.

The Series' annual management fee is 0.00% of the Series' value. Because this Fund is new, operating expenses and trading costs are not yet available.

3. Other fees

There are no other fees when you buy, hold or sell securities of the Fund.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.

For more information, see the securities law of your province or territory or ask a lawyer.

A word about tax

In general, you'll have to pay income tax on any money you make on the Fund. How much you pay depends on the tax laws where you live.

Keep in mind that distributions are included in your taxable income, whether you get them in cash or have them reinvested.
