## What does the Fund invest in?

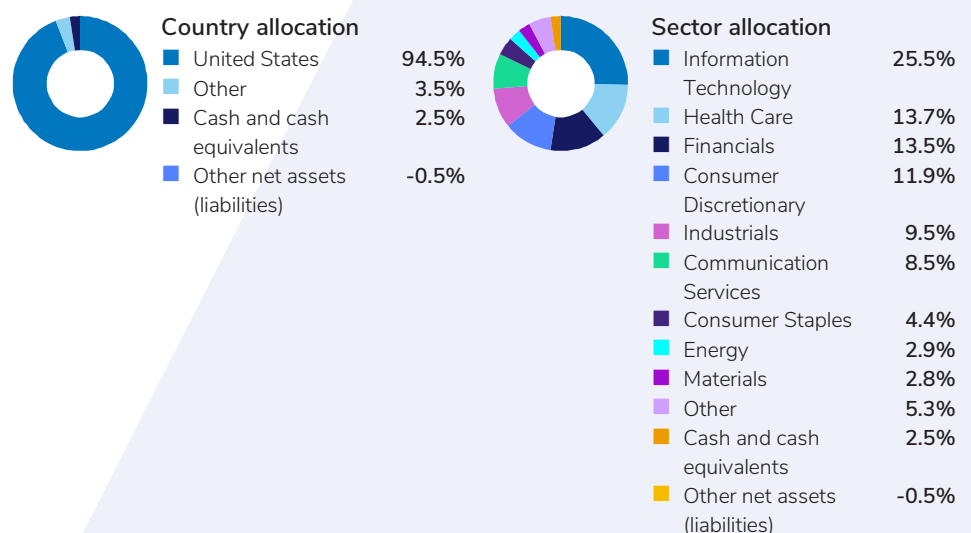
The Fund aims to provide long-term capital growth by investing primarily in U.S. equities through the allocation of assets to a number of mandates, including: U.S. Large Cap Value, U.S. Large Cap Growth, U.S. Core Equity, U.S. Small Cap and Private Investments. Each mandate is separately managed.

### How risky is it?

The value of the Fund can go down as well as up. You could lose money. One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility". In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### No guarantees

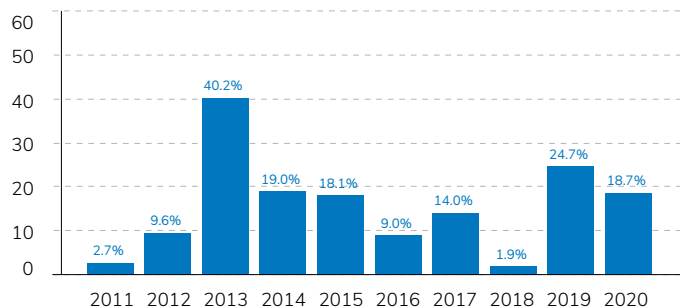
Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

### How has the Fund performed?

This section tells you how Series I securities of the Fund have performed over the past 10 years. Returns are after Fund expenses have been deducted. These expenses reduce the Fund's returns.

#### Year-by-year returns

This chart shows how Series I securities of the Fund performed in each of the past 10 years. The Fund did not drop in value in the past 10 years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



### Risk rating

IG Wealth Management has rated the volatility of this Fund as **medium**. This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

#### Best and worst 3-month returns

This table shows the best and worst returns for Series I securities of the Fund in a 3-month period over the past 10 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

#### Average return

A person who invested \$1,000 in the Series I securities 10 years ago would have \$5,052 as of September 30, 2021. This is equal to an annual compounded return of approximately 17.6%.

### Who is this Fund for?

You should consider investing in this Fund if you are comfortable with the risks for this investment and:

- your long-term investment goal is capital growth; and
- you intend to hold your investment in an iProfile account with either Investors Group Financial Services Inc. or Investors Group Securities Inc. If your iProfile account was opened on or after March 1, 2020, you cannot hold your investment in this Fund at an account with another dealer. If you wish to transfer your investment to another dealer, you may have to redeem your Securities, which may trigger fees and tax consequences associated with the redemption.

### How much does it cost?

The following section shows the fees and expenses you could pay to buy, own and sell Series I securities of the Fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### A word about tax

In general, you'll have to pay income tax on any money you make on the Fund. How much you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your Fund in a non-registered account, taxable fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

## 1. Sales charges

Generally, there are no purchase options available under the iProfile Program that attract sales charges. You pay only the iProfile Advisory Fee.

When you buy this series of the Fund, IG Wealth Management may pay your IG Consultant a sales bonus of up to 2.50%. IG Wealth Management may pay your IG Consultant an additional payment of up to 40% of the sales bonus if they are in their first four years with us.

## 2. Fund expenses

You don't pay these expenses directly. These expenses reduce the annual return of the Series.

As of March 31, 2021, the Series expenses were 0.66% of its value. This equals \$6.60 for every \$1,000 invested.

### More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the Fund. It is for the services and advice that your IG Consultant provides to you.

IG Wealth Management pays the trailing commission to your IG Consultant. It is paid in whole or in part from the iProfile Advisory Fee and is based on the value of your investment. The rate ranges between:

- 0.41% to 0.70% per year (\$4.10 to \$7.00 per year for every \$1,000 invested).

If your IG Consultant has been with us for more than four years, he or she may receive an additional annual payment of 0.06% to 0.09% of your investment (\$0.60 to \$0.90 for every \$1,000 invested).

## 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the Fund.

Fee	What you pay
<b>Inappropriate Short-term trading fee</b>	If you initiate a combination of purchases and redemptions, including switches into, or out from, the Fund within 30 days, your switches could have a detrimental effect on other Fund investors, and that may take advantage of Funds with investments priced in other time zones or illiquid investments that trade infrequently. We may charge you 2.00% of the amount you switch. This fee is payable to the Fund.
<b>Excessive Short-term trading fee</b>	If you initiate a combination of purchases and redemptions, including switches into, or out from, the Fund within 30 days, your switches could have a detrimental effect on other Fund investors, and we may charge you up to 2.00% of the amount you switch. This fee is payable to the Fund.
<b>Redemption fee</b>	You usually do not pay a redemption fee for selling securities of the Fund. However, if your investment was switched into the iProfile Program from another IG Wealth Management Fund or a Guaranteed Investment Fund and there was a redemption fee attached to it, we may charge you a redemption fee of up to 4.00% of the amount you redeem. If your original investment became subject to a redemption fee after June 30, 2016, any remaining deferred sales charge will be waived upon death of the individual owner (or last surviving owner for jointly held accounts).
<b>iProfile Advisory fee</b>	You pay an advisory fee directly to the Principal Distributors, as described in your agreement with them, for investment advice and administrative services if your investment is held with them. Under certain circumstances the Distributor may offer you a fee reduction. Please contact your IG Consultant for more information.

### What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
