## How risky is it?

The value of the Fund can go down as well as up. You could lose money. One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell P securities of the Fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

## 1. Sales charges

Generally, there are no purchase options that attract sales charges.

#### 2. Fund expenses

You don't pay these expenses directly. These expenses reduce the Series' annual return. The Series' expenses are made up of the management fee, operating expenses (including the administration fee) and trading costs. The Series' annual management fee is 0.0% of the Series' value. Because this Fund is new, operating expenses and trading costs are not yet available.

### 3. Other fees

There are no other fees when you buy, hold or sell securities of the Fund.

## What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
